# **Jeff Stoner:**



As a Yuma native of 50 years, I have attended school from kindergarten to college, married my wonderful wife, Christine, raised all three of our children, and own a successful electrical contracting business in this community I truly love, work in, volunteer in, and fully support.

Watching two of my children as they worked in the public education system as teachers and a FFA advisor, I experienced first hand what is going on in our public school system. I have watched while teachers are continuously losing their ability to properly and adequately instruct and discipline their students in the classroom. I have seen how teachers are forcibly paying out of pocket for even the simplest educational materials needed in their classrooms. I have learned how teachers are afraid to speak up due to not only the lack of peer support but also the threat of losing their job by not getting a contract renewal if they speak up. Recently, our schools have been tasked with addressing single sex areas and keeping our children feeling safe and comfortable in these areas. The three women on our current board and superintendent refuses to properly address this issue.

We need para's that are educated and experienced in the specific needs of these children. We need equipment in the classrooms, bathrooms, and on the playground to make these areas all inclusive for our children with special needs to participate with all children.
- -I believe in saving our public schools but also believe parents know what is best for their child and if they feel the public school system is failing them, they have a right to remove their child and pursue other forms of education by use of the ESA (empowerment scholarship account).
- -I believe in building a culture whereas the teachers can openly discuss their concerns, common issues, and offer opinions to make a better environment without the fear of losing their contract renewal.
